Chester County:

Directions to London Grove Township Municipal Building

From East or West on Baltimore Pike, Rt. 1, Take Rt. 841 South Exit. Drive approximately 0.2 miles south on Rt. 841. Turn left on Oakland Avenue and drive for approximately 0.2 miles. Turn left on Rose Hill Rd. Drive for a little under 1 mile and turn right into London Grove Township Municipal Building.

When following these directions, please ignore any other Lancaster County Park entrances.

From Lancaster: Follow Duke Street South through the city. As you leave the city, cross over the Conestoga River. Pass the Park entrance after the bridge and make the next right onto Eshelman Mill Road. Pass Golf Road and the Maintenance building and stay to the right at the Y. The Environmental Center is on the right shortly after the Y. The library shares the Environmental Center parking lot.
