

Directions to Lower Dauphin Middle School

251 Quarry Rd. Hummelstown, PA 17036

From Westbound US 322, take the Hummelstown/Middletown Exit. At the top of the ramp turn Right onto Quarry Road and go about 2 tenths of a mile to the entrance drive for the Lower Dauphin Middle School on the right.

From Eastbound US 322, take the Hummelstown/Middletown Exit. At the top of the exit ramp go straight and cross over Hanover Street. At the next light turn Left onto Quarry Road. Go about 3 tenths of a mile to the entrance drive for the Lower Dauphin Middle School on the right.
